Dear Members of the Board:

The Bauer Company is a manufacturer of concrete products, located in Armstrong and Butler Counties with 37 employees. The above referenced regulation as proposed could greatly jeopardize our business as cement use creates dissolved solids in discharge waters. In fact, most activity generates dissolved solids, sulfates or chlorides that have been well assimilated in receiving streams; this has not been adequately proven to be a problem.

Therefore, The Bauer Company requests the withdrawal of the proposed regulation. Thank you for the opportunity to comment on this proposed rulemaking.
