- 2) Approve and implement these standards as soon as possible in order to protect public health and our environment
- 3) Stop all new gas drilling operations until these new health-based standards are set and require all sewage treatment plants to follow these proposed standards immediately
- 4) Require drilling companies to track and report all of their pollution from drilling sites to treatment plants, and establish regulations to oversee the reuse of gas drilling wastewater.
