State Real Estate Commission Regulation16A-5615; Initial Licensure Fees Proposed Regulation

<u>PROPOSAL</u>: Regulation16A-5615 is a proposed regulation which was published on December 19, 2009. The House Professional Licensure Committee has until February 8, 2010 to submit comments on the Proposed Regulation.

Regulation 16A-5615 amends 49 Pa. Code §35.203, relating to fees, by consolidating a two (2) tiered fee schedule into one and by establishing the fees for initial licensure and registration for two categories of applicants.

<u>PROPOSED REGULATION ANALYSIS</u>: Title 49, §35.203, relating to fees, is amended by creating a new few structure for two categories of new applicants. Currently, fees differ depending on when, within a biennial period, the application for initial licensure or registration is submitted.

The current two-tiered structure precludes the State Real Estate Commission from participating in online applications for initial standard or reciprocal licensure a for broker, cemetery broker, branch office, rental listing referral agent or broker of record, partner or officer for a partnership, association or corporation and initial standard or reciprocal registration for a cemetery company or initial standard or reciprocal licensure for an associate broker, salesperson, cemetery associate broker, cemetery salesperson, builder-owner salesperson, time-share salesperson or campground membership salesperson.

The proposed amendment establishes \$94.50 as the fee for the initial standard or reciprocal licensure for a broker, cemetery broker, branch office, rental listing referral agent or broker of record, partner or officer for a partnership, association or corporation and \$72.00 as the fee for initial standard or reciprocal registration for a cemetery company or initial standard or reciprocal licensure for an associate broker, salesperson, cemetery associate broker, cemetery salesperson, builder-owner salesperson, time-share salesperson or campground membership salesperson.

A summary of the changes follows:

- Initial standard or reciprocal licensure for a broker, cemetery broker, branch office, rental listing referral agent or broker of record, partner or officer for a partnership, association or corporation will be \$94.50 and there will not be any delineation for each half of the biennial period. Please note the biennial renewal fee is \$126.
- Initial standard or reciprocal registration for a cemetery company or initial standard or reciprocal licensure for an associate broker, salesperson, cemetery associate broker, cemetery salesperson, builder-owner salesperson, time-share salesperson or campground membership salesperson will be \$72.00 and there will not be any delineation for each half of the biennial period. Please note the biennial renewal fee is \$96.

<u>RECOMMENDATION</u>: It is recommended that the House Professional Licensure Committee take no formal action until final regulations are promulgated and submit the following comments:

1. Of the 27 boards and commissions which are currently issuing licenses or registrations, the Committee requests information regarding which are able to use the Bureau of Professional and Occupational Affairs' licensure software allowing on-line application and which are not.
