As an organization that represents more than 30,000 of the Commonwealth's real estate licensees, the Pennsylvania Association of REALTORS® (PAR) welcomes the opportunity to provide input on the regulation titled "Fees" (16A-5615) as published in the December 19, 2009 edition of *The Pennsylvania Bulletin*.

The Commission currently offers a staggered rate for those applying for licensure during the biennial renewal cycle. The proposed regulation will revise the initial licensure fee structure from a two-tier system to a one-tier system in order for the Commission to accept on-line initial licensure applications.

PAR has discussed this regulatory revision and, taking into consideration that the Commission is not increasing licensing or renewal fees, we remain neutral on this concept.
