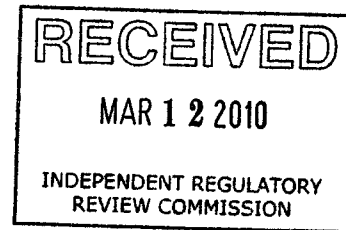

To Whom It May Concern:

This firm represents the Borough of Lansdale ("Lansdale") with respect to the Environmental Quality Board's ("Board") proposed amendments to the NPDES Rules. Specifically, the Board proposes to rescind 25 Pa. Code Chapter 92 and replace it with a new Chapter 92a of the same name ("Chapter 92a Regulations").

The purpose of this letter is to request that the Board extend the period in which interested parties may provide comments on the proposed Chapter 92a Regulations. The proposed regulations are complex and expansive. In order to review the proposed regulations and provide meaningful comments, especially considering their breadth, the comment period should be extended. Therefore, Lansdale respectfully requests that the Board extend the comment period for at least an additional 30 days.

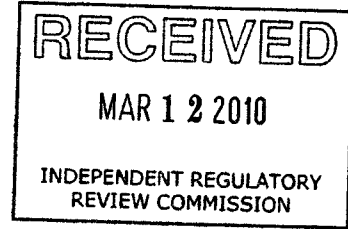
