Please consideration the intent of 20.42 Standards of professional conduct, (b) A massage therapist may not: (12) "Refuse a client's request for a refund for the unearned portion of prepaid or packaged massage therapy services. This provision does not apply to gift certificate purchases."

I agree that a requested refund should be granted for unearned portion of prepaid services, with one other exception. The exception is when a client makes advances toward the therapist and the therapist immediately discontinues the session. In this situation, I think the therapist should have the right to refuse a refund and demand that the client leave.

Is it possible to include this exception in the General Provisions / Guidelines?
