RE: Residential Treatment Facilities Regulations No. 14-522

On behalf of MOMSTELL, It is extremely difficult for family organizations to go through this lengthy document thou thoroughly in the 30 day time period allotted. I will express some of the concerns that I do have regarding the document, but have not had the time to go through this document with a clear understanding of how these regulations affect substance abuse and co-occurring disorders.

- In looking at section 23.57- regarding Mental Health workers and Aids. Nothing is mentioned about D&A training. That would definitely have impact on their care. So how will that affect those youth who have substance abuse/co-occurring disorders?
- In 23.58 the only requirement for an overnight watch for children in the RTF is be over 21 and have a highs school education. This is concerning to me that if anything were to happen to a child during the night, it is possible the only" required" responder could be this untrained 21 year old.
- In 23.60- What is the definition of a "family advocate"? Are these advocates trained in MH/SA? What are the age requirements? What about the peer specialists that can be paid already by MA, could they be utilized?
- Also in section 23.62 under staff training, I do not see D&A training listed or training for co-occurring disorder.

As I said prior, I am sure there are other things that need to be addressed but I would need more time to review this document. I would ask that the time for comments be extended so that a more comprehensive review could take place.
