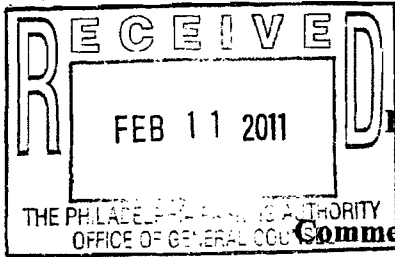

Comments of the Pennsylvania Public Utility Commission

The Pennsylvania Public Utility Commission (Commission) submits the following comments to the Proposed Rulemaking. The Commission's comments are limited to those proposals that may impact Commission certificated carriers.

Proposed Regulation

52 Pa. Code § 1051.18 Method of Operation.

This provision defines, generally, the method of operation for limousine service within the Philadelphia Parking Authority's (PPA's) jurisdiction. The provision should include all types of limousine service falling within the PPA's jurisdiction. The Commission submits that this provision should be modified consistent with 53 P.S. §§ 5701 and 5741, to clarify limousine service operations subject to PPA oversight. Specifically, the proposed regulation should address limousine service delineated at 53 P.S. §§ 5701(1)(ii) and 5741(a.2) (limousine service provided as non-exclusive, scheduled, and non-advanced reservation to or from an airport, railroad station, or hotel located in Philadelphia).

52 Pa. Code § 1053.1 Standard Classifications of Limousine Service.

The Commission submits that this provision should be modified consistent with 53 P.S. §§ 5701 and 5741, to clarify limousine service operations subject to PPA oversight. The proposal addresses airport transfer service, a specific subcategory of limousine service. However, as defined in the proposal, it is inconsistent with 53 P.S. § 5741(a.2).

52 Pa. Code § 1053.32 Method of Operation.

The Commission submits that this provision should be modified consistent with 53 P.S. §§ 5701 and 5741, to clarify limousine service operations subject to PPA oversight. The proposal addresses airport transfer service, a specific subcategory of limousine service. However, as defined in the proposal, it is inconsistent with 53 P.S. § 5741(a.2).
