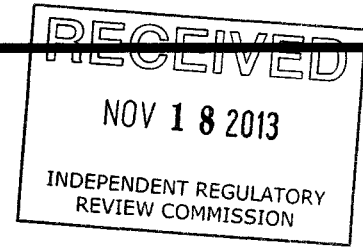

MY NAME IS TONI E. LYNCH, A BANGOR PA AREA SCHOOL DIRECTOR, I AM AND HAVE BEEN A SELF EMPLOYED BUSINESS MAN FOR 40+ YEARS, I AM ALSO A FORMER MILITARY OFFICER, TRAINED TO DETECT COMMUNIST SUBVERSIVE IMPLIMENTATION IN SMALL VILLAGE COMPLEXES.

HAVE WE LEARNED NOTHING FROM THOSE STATES WHO ARE FURTHER ALONG IN IMPLEMENTING COMMON CORE, AND THE ISSUES THEY HAVE FACED CONCERNING THE FAILURE CURRENTLY BEING GENERATED ALL OVER THE COUNTRY BY THIS DECEPTIVE EFFORT TO NATIONALIZE OUR EDUCATION SYSTEM.

IS THIS NOT AN EVEN GREATER FRAUD ON THE AMERICAN PEOPLE THAN THE CURRENT HEALTH CARE DEBACLE? IT IS ALARMING HOW CLOSELY THE IMPLEMENTATION OF COMMON CORE PARALLELS THE IMPLEMENTATION OF THE AFFORDABLE CARE ACT.
