Hi Sarah: Some General Comments:

Section 511.2 Definitions

- Include Planning Partners: are Metropolitan Planning Organizations (MPO) or Rural Planning Organizations (RPO) under contract to the Pennsylvania Department of Transportation – if nothing else then for consistency with required Long Range Transportation Plans and TIP
- Should include "Multi-modal Fund"
- Should include "Intermodal or Inland Port"

Section 511.3 Eligibility

- (b): Can the 30% match be "Cash, In-kind or a combination of"
- How will you handle consistency with Statewide Freight Plan and or MPO/RPO Long Range **Transportation Plans**
