After reviewing the draft regulations, I would like to suggest inserting the following addition to Section 511.6 concerning the Application submission procedure:

Applicants are strongly encouraged to coordinate the preparation of applications with the representative metropolitan planning organization or rural planning organization (i.e., prior to submission).

The Commonwealth's MPOs, RPOs, and their city and county planning partners are very interested in rail freight operations, facilities, and solutions. Becoming familiar with the candidate projects "early on" would foster the provision of more meaningful input to PennDOT during the review process, and it also lays the groundwork for improved and expanded candidate project submittals in future years.
