I submit these comments in support of the Environmental Quality Board's proposal togamend the Pennsylvania Code to provide an extra layer of protection to approximately 207 miles of Pennsylvania's streams. 46 Pa. Bull. 1205 (March 5, 2016).

Pennsylvania's water resources are essential to the commonwealth's health and economic wellbeing, and they should be given the strongest possible level of protection.

I strongly support the addition of the stream segments listed in the March 5, 2016 Pennsylvania Bulletin announcement to the list of "High Quality" waters in Pennsylvania. Objective scientific data reveal that these streams are among the best of Pennsylvania's wild trout fisheries. Designating these stream segments "High Quality" will help provide them with an additional layer of protection to ensure that they continue to serve as a viable habitat for aquatic life.
