To Whom It May Concern:

My name is Anthony George. The purpose of this correspondence is to protest IRRC #3146 & 3147, the changes to the vaccination policy for all school-age children in the Commonwealth of Pennsylvania.

My wife and I stand firmly against vaccines. They are a violation of our religious beliefs. Furthermore, there is overwhelming evidence that vaccines are connected with Autism, and countless other serious health issues. This was vindicated for us by a personal experience with a relative when she was a child, to the point where her medical provider admitted that it was the shot that caused her Autism, for she was a perfectly normal child prior to the vaccine.

Regarding a health care provider having to provide proof of natural immunity from chicken pox: Taking a child into a clinic who obviously has chicken pox, for the sole purpose of obtaining an official diagnosis, creates the risk of the sickness being spread to others in the office.

With regards to the requirement of the Pertussis vaccine for children entering kindergarten; there are a multitude of outbreaks of this disease, even in fully vaccinated communities. Even the CDC and other top experts are admitting that this vaccine is not as effective as we are led to believe. Why require a new vaccine to the schedule which is still not bearing the desired results and is a risk factor in causing serious adverse health conditions?

With the passing of the 1986 National Childhood Vaccine Injury Act by Congress, it was shown that Meningitis and Tdap vaccines are toxic. Since 1988, more than \$3.2 billion has been awarded to children and adults injured by vaccines or who have had family killed by vaccines.

Since the passing of the 1986 Law,, which partially shielded drug companies manufacturing vaccines from civil liability, vaccine manufacturers have been freed from any civil liability. In 2011, these same companies were fully freed from any liability for FDA licensed and CDC recommended and state mandated vaccines which have proven harmful to children and adults. Hence, the only way for Americans as a whole to protect themselves from the risks associated with vaccines are flexible and non-medical vaccine exemptions.

With regards to requirements for standardized language in communications regarding vaccine requirements: We desire that all schools use the same language that clearly outlines the accepted exemptions as stated in the text of 28 PA CODE CH. 23

Regarding the addition of the meningococcal vaccine for students entering the 12th grade, post-marketing observation has found the following: hypersensitivity reactions such as

anaphylaxis/anaphylactic reaction, wheezing, difficulty breathing, upper airway swelling, urticaria, erythema, pruritus, hypotension, Guillain-Barré syndrome, paraesthesia, vasovagal syncope, dizziness, convulsion, facial palsy, acute disseminated encephalomyelitis, transverse myelitis, and myalgia.

I urge you to not pursue the change to vaccine policy, and not to take away our right to the current exemptions. It is a firm decision not to vaccinate, based on our religious beliefs, and evidence that the vaccines, with their harmful ingredients, do far more harm than good.
