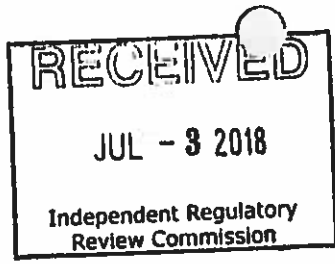

Re: Request to Extend Public Comment Period for Overtime Proposal

Dear Mr. Smolock:

We write on behalf of our organizations, representing a broad range of Pennsylvanians and employers in the Commonwealth, regarding Regulation #12-106, amendments to 34 Pa. Code Chapter 231 with respect to Overtime Pay.

We respectfully request that the Department of Labor & Industry utilize its right under the Regulatory Review Act to extend the public comment period beyond 30 days. (1 Pa. Code § 305.3(b))

While Pennsylvanians will no doubt have diverse views on the proposed rule, presumably everyone agrees with the potential for this proposal to have a profound impact on many employers and employees. Everyone should further agree that all stakeholders deserve the opportunity to understand the proposal and provide comment if they so choose.

An employer, for example, might believe it prudent to conduct a thorough assessment of existing operations and personnel; examine the changes proposed under the rule and attempt to determine their applicability and impact. This may include reviewing job descriptions and personnel policies, interviews with employees and consideration of budgetary impacts and possible adjustments. After a comprehensive internal review, an employer may very well feel compelled to produce comments for consideration by your agency.

Thirty days is simply not enough time to allow this process to run its course. And, in reality, Pennsylvanians have just twenty work days since the notice was published; that is, assuming they became aware of the rule on Saturday, June 23rd when it was published in the PA Bulletin. Despite our organizations' efforts to alert our respective members, it is likely a significant segment of the impacted population may not yet be aware of the proposal.

The Regulatory Review Act provides that "An agency may extend or reopen the public comment period by delivering notice to the Commission and the committees, and publishing a notice in the Pennsylvania Bulletin that specifies the close of the extended or reopened public comment period."

Agencies were given this discretion for just these types of circumstances, and accordingly, we again respectfully request an extension to the public comment period. We believe an additional 60 days would be appropriate and welcome the opportunity to discuss with you.

Thank you for considering our views on this important matter.
