Hello! My name is Kinsey Gensel and I am the owner/operator of Kinsey Massage Therapy. I have been a certified then licensed therapist for over 13 years, but really my interest in the field spans well over 20 years. While I have many interests, outlets, and loves, massage is my full time occupation and passion and will be for at least the next decade. So I am viewing this from a long term perspective both future and past.

This proposed rate increase is first wholly unfair to expect therapists to dig the board out of a hole they have solely created and to which we have no control over. May I suggest they find some part time jobs to recover the costs? Or a bake sale? Sell lemonade? I do dog sitting on the side so I can fund my meager camping vacations for myself, children and dogs and also volunteer at a CSA in exchange for vegetables every week.

Secondly, a quick glance at the fees of other PA occupations you'll find that estheticians and cosmetologists pay slightly less than we do biannually, \$67 (I believe) while chiropractors pay \$210 biannually. So are you to say we are now on the same level as chiropractors? Well, congratulations to us then! I hope the rest of society follows your lead. Maybe then we could start racking in closer to 6 figures like the chiropractors I know. Not that I'm doing this for the money, the respect would be swell too. Maybe I'd get less sexual solicitations. No. That certainly hasn't slowed down in the years since licensing, but I could have sworn that was supposed to be a side benefit? Yes?

Thirdly, this will increase the rates of continuing eds and I'm not sure you want me to go there at this point. Well, I will anyway. I have many complaints when it comes to continuing eds and I might as well air them. Another forced requirement of licensing...

24 credits every 2 years is an absurd amount of extra education for a field where there are very few new advances. This isn't our fault and we shouldn't have to shoulder the burden of cost for something we are seemingly getting little out of in return, have now lost our good faith in the current board, and for what many of us never wanted in the first place. So, no, I do not agree with any of the rate increases.
