Good afternoon all. My name is Hannah Enderby, and I am a 4th year environmental science & management student and researcher at Duquesne University. I am also on the executive leadership team for the environmental Justice club at Duquesne, called Evergreen. Evergreen's mission is to create and promote environmental awareness, and one of the ways in which we bring our mission to fruition is through peaceful, political activism. My club sees protecting and improving the environment as essential to creating a more just world and planting seeds of hope for the future. For this to happen, we need to reduce the pollution that is responsible for climate change- one of these potent, greenhouse pollutants being methane. I fully support the passing of the PA methane ruling. Everyone knows what our unchecked

release of greenhouse gases into the atmosphere has caused- violent storms, severe droughts, mass extinctions, hotter/longer summer, and even a newly coined health term called "climate anxiety," and the list goes on and on and on. We also know that these things have the greatest impact on those that are already marginalized in our world. Climate changes affects the poor and marginalized to a MUCH greater degree than it affects the privileged. The significantly higher rates of cancer, asthma, and decline in overall quality of life is alarming in environmental justice areas. I would understand since I struggle with asthma, and it has progressively become worse as the air quality worsens.
