States already participating in this program have been able to cut their carbon pollution by 47%, almost in half.

By requiring power plant owners to pay for their pollution, we'll cut emissions even faster and we'll be able to invest the money raised into projects that transition us away from harmful fossil fuels, prioritize clean energy and energy efficiency, and overall protect our environment and our health. To date, RGGI has raised over \$2.5 billion in participating states for these types of projects, which only further helps us combat the impacts of climate change we've already begun to experience.

When I walk along the converted rail park in my neighborhood, or sit in my home that was once a factory and is now equipped with modern-day clean energy technologies, I am grateful and inspired by the power to take something old, and antiquated, and transform it into something wonderful, and new. By joining RGGI, Pennsylvania has the opportunity to pursue the transformation of our energy economy, from our polluting past to a clean future, while cutting the carbon emissions we so desperately need to reduce.

That's why I support Pennsylvania joining the Regional Greenhouse Gas Initiative, to help us reduce climate pollution and invest in the sustainable, clean energy future our communities need and deserve. I look forward to seeing what type of future we can imagine and build together. Thank you.
