My story is short. I live spitting distance from the railroad tracks where oil and gas trains run day and night. I can see them from my kitchen window. If there is an accident, I am dead. Not a happy thought.

I have been fighting fracking in southwestern, PA since 2010 when pgh had its first protest downtown. I was there. Ten years later and we are still fighting the same fight. It is time fossil fuels were left in the ground where they belong and look to creating sustainable energy by using wind and sun. But until that time, the fossil fuel industry must dramatically reduce its emissions and pay its fair share for the air, water, and soil pollution they have caused. RGGI is a step in that direction.

Many Residents of PA are sick. They have respiratory illnesses, heart attacks, strokes, cancer, and mental health problems. And many less serious illnesses but still debilitating like headaches,
