"Pennsylvania must join the Regional Greenhouse Gas Initiative (RGGI)"

As one of the largest climate polluters in the country, Pennsylvania's joining would have an enormous impact on the reduction of carbon emissions into our skies.

By joining RGGI we can reduce harmful air pollution that affects everyone's health, especially the health of the more vulnerable, like me.
