I'm writing on the behalf of the Berwick Area School District to proudly voice our support for Pennsylvania joining the Regional Greenhouse Gas Initiative (RGGI). This letter was unanimously approved by all nine board members at the January 11, 2021 meeting of the Berwick Area School Board.

The ongoing COVID-19 pandemic has taught us just how important healthy lungs are. Unfortunately, Pennsylvania is the country's fourth-largest producer of carbon emissions, and all that air pollution chips away at our lung health and puts residents at even greater risk of respiratory illnesses like COVID-19.

However, the main benefit of RGGI is the major role nuclear power plays in the state of Pennsylvania, not to mention the Berwick Area School District. As the Chair of the Budget Committee for the Berwick Area School District, I see firsthand the vital role nuclear power plays in our yearly budget since we have the Susquehanna Steam Electric Station located within our school district.
