Please accept this letter on behalf of the Millville Friends Meeting (Quakers) of Millville, PA. As concerned citizens who value stewardship of the earth, we join with the Lewisburg Meeting, whose letter of support you have already received, in strongly supporting the Commonwealth of Pennsylvania's agreeing to abide by the standards and programs of RGGI.

Pennsylvania's electricity-generating units (EGUs) rank 4th highest among CO2-emitting EGUs in our country, as your Board has stated. The serious problems resulting from CO2 and other greenhouse gases are shared by all, and this global challenge requires regional cooperation.
