I wholeheartedly endorse the proposed rule for a carbon dioxide budget trading program, as iterated by the Pennsylvania Environmental Quality Board. In shorter parlance, I believe my home state of Pennsylvania absolutely should join the Regional Greenhouse Gas Initiative (RGGI).

Relative to all other states that have thus far participated in RGGI, Pennsylvania stands out as the state whose economy is most reliant on the production of fossil fuels. This fact renders Pennsylvania one of the greatest emitters of carbon dioxide pollution in the entire United States. The Commonwealth therefore has a moral imperative to lead the way in the transformation of its energy supply to one that mitigates the climate crisis rather than perpetuates and exacerbates it.

For more than a decade now, the RGGI program has vividly demonstrated its multi-faceted success in the other member states: carbon emissions have substantially decreased, citizens of low-income have received financial assistance with their energy bills, electricity prices have decreased, renewable energy infrastructure has increased, and state economies have indeed improved.

The specific achievements of RGGI to date are quite impressive. According to a 2019 analysis by

the Acadia Center, electricity prices decreased 5.7% in RGGI-member states between 2008 and 2017, while states not participating in RGGI witnessed an overall increase in electricity prices of 8.6% during that same period. Additionally, RGGI-member states have enjoyed 31% more economic growth than the rest of the nation between 2008 and 2018, and carbon dioxide emissions decreased 90% faster in RGGI-member states relative to the rest of the United States. Even the most skeptical perspective on these figures cannot deny the fact that the implementation of RGGI has not antagonized economic growth.

Pennsylvania now faces a precious opportunity to join this powerful program and prove to the rest of the nation - and even the world - that market-based carbon trading mechanisms can simultaneously lower greenhouse emissions and other air pollutants AND stimulate the economy. I am confident that RGGI will manifest remarkable progress in Pennsylvania, and once there are numbers to validate this progress, it will clearly signal to outsiders that carbon pricing is the most expedient solution to the climate crisis. Pennsylvania can then take great pride in its national and global leadership. The time for Pennsylvania to join RGGI is right now, the world cannot wait.

I just graduated with a Masters of Science in Environmental Studies from Antioch University New England. During the Spring 2020 semester, I took a doctorate-level Political Economy course, and I studied RGGI and its relevance to my home state of Pennsylvania.
