As a small business owner couple, we strongly oppose Pennsylvania's entry into the Regional Greenhouse Gas Initiative (RGGI). Increasing electricity costs will negatively affect our business, an auto service organization employing seven, counting the owners. To compensate for increased overhead, we cannot raise prices, and we cannot reduce our workforce without reducing our revenue.

The COVID-19 pandemic has made it especially hard for small businesses to compete and succeed, and economic challenges will remain for the foreseeable future. There could be no worse time to burden businesses like ours with the higher energy costs that RGGI would bring to Pennsylvania.

We are also concerned about the thousands of jobs that will be lost when coal and natural gas-fueled power plants in the state are shuttered. Even more jobs would disappear in the communities surrounding them and the small businesses that support them, including manufacturing, transportation, raw materials, and vendor services. The ripple effect from these losses would impact the whole economy.

At a time when Pennsylvania's small businesses are suffering, RGGI would just set us further back. This seems especially irrational when modeling shows that RGGI will have little impact on

CO2 emissions over time.

Please reconsider this course of action and withdraw this burdensome, anti-small business, carbon tax regulation!
