I have long been following the issues with concerns that CO2 emissions are causing global warming. It has a long history of dubious science, and a strong political component to it.

The fact that more of the temperature increase has occurred at night, strongly supports the idea that a lot of the data showing increase is triggered by urbanization, not CO2. This occurred because of the closures of many temperature stations from remote locations has caused us to have a larger percentage of data from areas that have undergone increased urbanization. Much of the data is coming from "poorly seated" temperature stations that decreases the reliability of the data, and artificially increases it.
