While those in favor of this proposal cite the widespread agreement among climate scientists about human activity causing changes to global climate, that is not an informative observation. Of course, humans have an effect on climate, but so do volcanoes, wild fires, and meteorites among virtually everything else. What I would like to see before any more climate legislation proceeds is a comparison of what may be saved by #7-559 to the CO2 emissions from said volcanoes and wild fires, keeping in mind that the severity of wild fires can be reduced by better forest management.
