Pennsylvania's General Assembly created the Independent Regulatory Review Commission to provide independent oversight of the rulemaking process in Pennsylvania and to establish an ongoing and effective review of agency regulations. The Commission's mission is to review agency regulations in order to determine whether they are in the public interest. By evaluating the conformity of rulemakings with law, and their impact on the public and regulated community, we assist the General Assembly and the Governor in achieving a favorable regulatory balance and ensure the integrity of the regulatory process. This annual report details the Commission's activities in 2016.

In 2016, the Commission reviewed a total of 75 regulations, including 32 proposed and 43 final regulations. More than 4,700 public comments were submitted on pending regulations in 2016. 117 members of the House and Senate submitted comments on these regulations. Standing Committees submitted formal comments on seven rulemakings.

Notable regulations reviewed by the Commission in 2016 include: School Immunizations (Department of Health #3147); Environmental Protection Performance Standards at Oil and Gas Well Sites (Environmental Quality Board #3042); and Implementation of the Alternative Energy Portfolio Standards Act (Public Utility Commission #3061). A full list of the regulations received by the Commission in 2016 is attached.

Looking ahead, the Commission will continue its role as an independent oversight body reviewing agency regulations and determining whether the criteria set forth in Pennsylvania's Regulatory Review Act have been satisfied.

- ABL** **Approved by Law** – The final regulation was deemed to be approved because the Commission did not submit any comments on the proposed regulation, the regulation was not modified from its proposed form and the designated standing committees did not disapprove the final regulation.
- APP** **Approved** – The final regulation was approved.
- DIS** **Disapproved** – The final regulation was disapproved by the Commission at its public meeting.
- N/A** Indicates this was a final-omitted regulation and was, therefore, not published in the *Pennsylvania Bulletin* for public comment.
- NONE** The Commission did not submit any comments on the proposed regulation.
- TOL** **Tolled** – A temporary timeout to stop the running of review timelines.
- WAD** **Withdrawn After Disapproval** – After an initial disapproval, the regulation was withdrawn.
- WBL** **Withdrawn By Law** – After an initial disapproval, the Agency did not resubmit the regulation within 40 days of the disapproval order and therefore, by law, it was deemed to be withdrawn.
- WDN** A final regulation submitted but withdrawn prior to Commission action. A withdrawn final regulation may be resubmitted within two years after the close of the public comment period. A withdrawn final-omitted regulation may be resubmitted as a new final-omitted regulation at any time.
